

ARTICLES OF ORGANIZATION OF BISHOP & MILLS PLLC

The undersigned, an authorized representative of a prospective member, desiring to form a professional limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, and the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, hereby adopts the following Articles of Organization:

ARTICLE I - NAME

The name of the professional limited liability company is Bishop & Mills PLLC (the "Company").

ARTICLE II - ADDRESS

The street and mailing address of the Company's principal office are:

ARTICLE III - PURPOSE

The Company is organized for the purpose of performing legal services and all other lawful business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - DURATION AND EXISTENCE; EFFECTIVE DATE

The Company will exist perpetually. These Articles of Organization shall be effective as of January 1, 2019, unless the filing of these Articles of Organization occurs more than five (5) business days thereafter, in which event such existence commences on the date of filing of these Articles of Organization with the Secretary of State of the State of Florida.

ARTICLE V - REGISTERED OFFICE AND AGENT

The Company (i) designates One Independent Drive, Suite 1200, Jacksonville, Florida 32202 as the street address of the Company's registered office, and (ii) names Contega Business Services, LLC, as the Company's registered agent at that address.

ARTICLE VI - MANAGEMENT AND AUTHORITY

The Company shall be a manager-managed company. Pursuant to Section 605.04074, Florida Statutes, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.

ARTICLE VII - INDEMNIFICATION

To the fullest extent not prohibited by law, the Company shall advance reasonable indemnification expenses (including attorneys' fees and costs) for actions taken in the capacity of such person as a manager, member or officer within twenty (20) days after receipt by the Company of (i) a written statement requesting such advance, (ii) evidence of the expenses incurred, and (iii) a written statement by or on behalf of such person agreeing to repay the advanced expenses if it is ultimately determined that such person is not entitled to be indemnified against such expenses.
