Pursuant to the provisions of Section 605.0202, *Florida Statutes*, this Florida limited liability company adopts the following Articles of Amendment to its Articles of Organization:

A. The name of this Company is **COVENANT HELP AT HOME, LLC**.

B. The Company's Articles of Organization were filed **January 3, 2019**.

C. Article I of the Articles of Organization is hereby amended and restated in its entirety to read as follows:

**"ARTICLE I - Name**

The name of the Limited Liability Company is **COVENANT CAREGIVERS, LLC** (hereinafter the "Company").

D. Article IV of the Articles of Organization is hereby amended and restated in its entirety to read as follows:

**"ARTICLE IV - Purpose**
