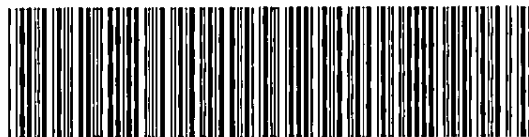

The purpose of this entity is to engage in a variety of real estate related projects and ventures; and any other activities as may be permitted by law.

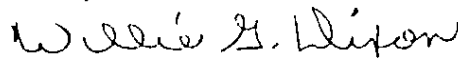

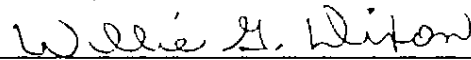
