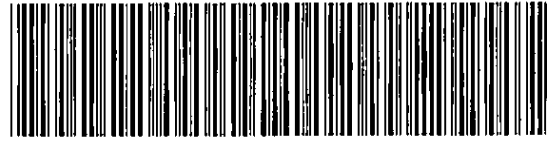

Registered Agent and Office



ARTICLE IV


Management of Business


