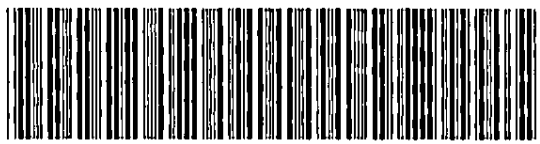



**ARTICLE I.
NAME**

The name of the Limited Liability Company is "*Teague Plaza, LLC*" (the "*Company*").

**ARTICLE II.
ADDRESS**

The mailing address and street address of the principal office of the Company is 935 SE 42nd Street, Ocala, FL 34480.

**ARTICLE III.
DURATION**

The period of duration for the Company shall be perpetual unless the Company is earlier dissolved in accordance with either the provisions of the *Florida Revised Limited Liability Company Act*, Sections 605.0101 through 605.1108 of the *Florida Statutes Annotated* (the "*Act*") or the Company's Operating Agreement among the members (the "*Operating Agreement*").

**ARTICLE IV.
MANAGEMENT**

The Limited Liability Company is to be managed by a Manager or Managers.

**ARTICLE V.
PURPOSE**

The purpose for which the Company is being organized is to acquire and develop, whether in its own capacity or as joint venture partner, real property, and thereafter to manage the same and ultimately sell the same, and also to transact any other lawful business approved by the Members of the Company and for which a limited liability company may be formed under the laws of the State of Florida.


