



ARTICLES OF ORGANIZATION FOR TEAGUE PLAZA, LLC A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I.

The name of the Limited Liability Company is "Teague Plaza, LLC" (the "Company").

ARTICLE II. ADDRESS

The mailing address and street address of the principal office of the Company is 935 SE 42nd Street, Ocala, FL 34480.

ARTICLE III. DURATION
