**ARTICLE V — MANAGEMENT AND AUTHORITY:**

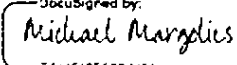

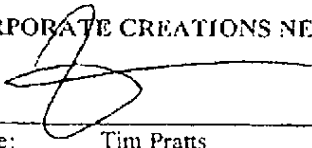
