





Articles of Organizations OF Coco Auto Trading, LLC.



KNOW ALL MEN BY THESE PRESENTS: That Fernando Nolberto and Mercedes Aponte desiring to form a limited liability company for the purposes set forth herein and in conformance with the Florida Limited Liability Company Act, do establish:

- 1. Company Name: That the name of the limited liability company is Coco Auto Trading. Limited Liability Company.
