

ARTICLES OF ORGANIZATION FOR JUST B CLAUS, LLC FLORIDA LIMITED LIABILITY COMPANY

Pursuant to Florida Statutes Chapter 605 et seq. "The Florida Revised Limited Liability Company Act" as amended, the below named entity adopts these Articles of Organization as of the date and time when these Articles of Organization are filed, as evidenced by the Department of State's date and time endorsement on this original document, in accordance with the following:

ARTICLE I - NAME

The name of the Limited Liability Company is JUST B CLAUS, LLC

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Limited Liability Company is 12102 Tripletail Lane, Orlando, Florida 32827.

ARTICLE III - REGISTERED AGENT

The name and the Florida street address of the registered agent are:

Having been named as registered agent and to accept service of process for the above named limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. <u>ARTICLE IV – MANAGEMENT</u>

The company shall be "member-managed" in accordance with the regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. ARTICLE V - DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved earlier as provided in the Operating Agreement of the Limited Liability Company.

ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his interest only as set forth in the regulations of the company.

<u>ARTICLE VII – MEMBER'S RIGHT TO CONTINUE BUSINESS</u>

The unanimous approval of the remaining members is required to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in this limited liability company.

ARTICLE VIII - CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the company by way of cash or property.

<u>ARTICLE IX – ADDITIONAL CAPITAL CONTRIBUTIONS</u>

Each member shall make additional capital contributions to the company only on the unanimous consent of all members, or as provided in the regulations.
