Articles of Organization of the RDC Site Services, LLC

A Florida Limited Liability Company

The undersigned Organizer desires to form a limited liability company under the Laws of the State of Florida by delivering these Articles of Organization in duplicate to the Secretary of State of the State of Florida, in accordance with the Florida Revised Limited Liability Company Act (the Act).

Article One Name

The name of the limited liability company, referred to as the Company, is:
