ARTICLE I - Name

The name of the limited liability company (hereinafter referred to as the "Company") is "RSJJ JV, LLC."

ARTICLE II -- Address

Article V - Classes of Membership

Article VII - Transferability of Membership Interests

Except as otherwise provided in the Operating Agreement, no member may transfer all or any part of his or her interest to any person, whether voluntarily, involuntarily or by operation of law, without the prior written consent of all of the members, which consent may be withheld in the sole and absolute discretion of the members. Transfer includes the sale, exchange, pledge, encumbrance or other transfer or disposition by a member of any part of his or her interest, whether for vidumble consideration or as a gift. Furthermore, in no event shall any transfered or assigned of an interest have any right to be admitted to the Company as a member, whether or not the transfer was approved by the prior written consent of all of the members. Unless etherwise provided in the Company's Operating Agreement, distributions upon liquidation, or prior to liquidation, guaranteed payments for services or guaranteed payments for the use of capital, and any other return of capital, preferential or otherwise, is at the sole and absolute discretion of the Manager, who is not required to be a member, and whose election, appointment, or removal may be restricted by the Operating Agreement, or may require the written consent of all-voling members, or of the Manager.
