**ARTICLE I - NAME**

The name of the limited liability company is VIBRANT COMMUNITY PARTNERS, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

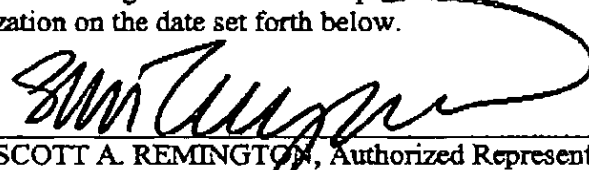

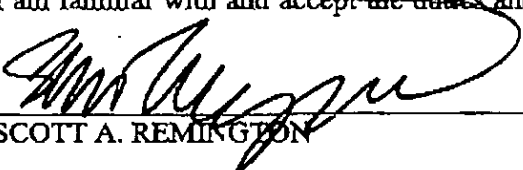
