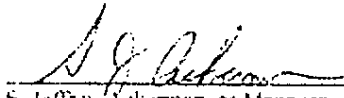
- A: The Articles of Organization were filed on January 24, 2019, to be effective as of January 24, 2019, and were assigned document number L19000019791.
