# ARTICLES OF ORGANIZATION OF BON CHANCE LLC

The undersigned subscriber to these Articles of Organization, desiring to form a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, and being a natural person competent to contract, hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a limited liability company under the laws of the State of Florida.
