ARTICLE V. MANAGEMENT OF COMPANY

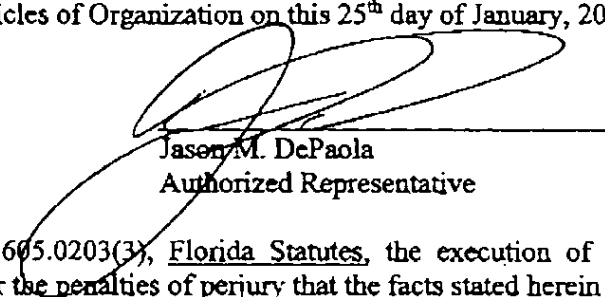

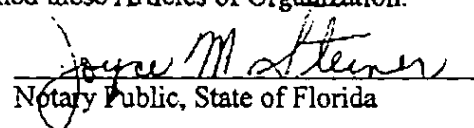

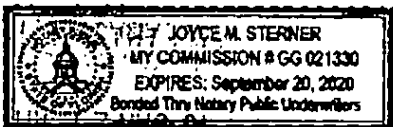
