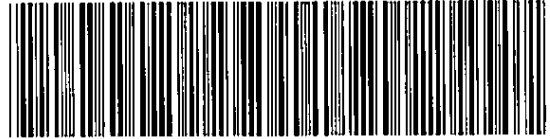

Bungalow Boutique Llc) are equal partners. Thank you.


