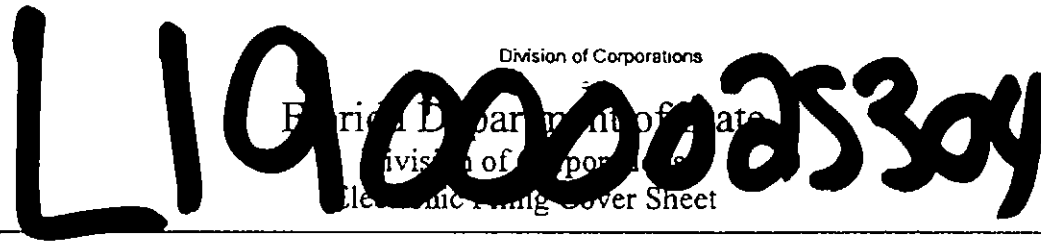

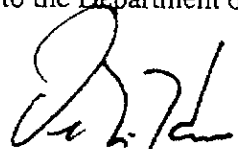
**ARTICLE IV — Operating Agreement:**
