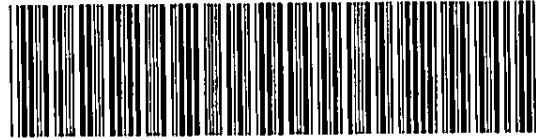

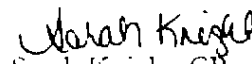

The street address and the mailing address of the principal office of the Company are 1704 Avondale Avenue, Jacksonville, Florida 32205.

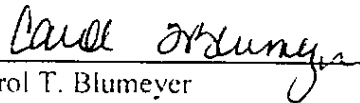
ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

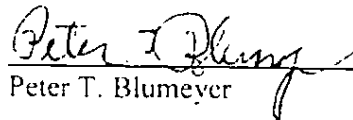
