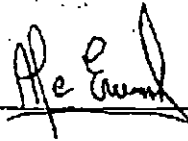

Continuity of Life

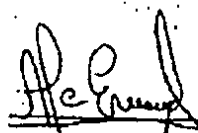

Article IX

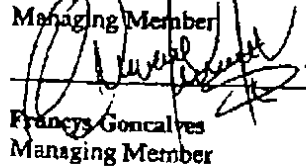
Management
