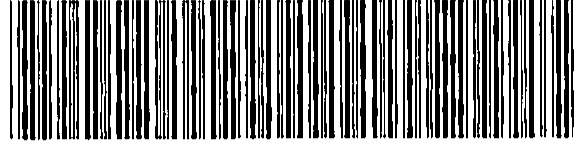

The undersigned, being the members of DAYWORLD TRADE & SERVICES LLC, adopts the following Amended and Restated Articles of Organization pursuant to the authority and provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act:

**FIRST:** The name of the limited liability company filing these Amended and Restated Articles of Organization is DAYWORLD TRADE & SERVICES LLC (the "Company").

The Articles of Organization of the Company were filed with the Corporation Division of the Florida Department of State on February 4, 2019 under Document No. L19000028770.
