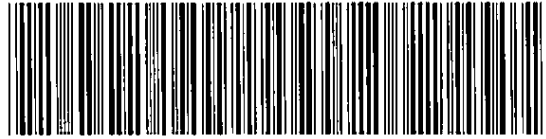

ARTICLES OF ORGANIZATION
OF
DAYWORLD TRADE & SERVICES LLC**

The undersigned, being the members of DAYWORLD TRADE & SERVICES LLC, adopts the following Amended and Restated Articles of Organization pursuant to the authority and provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act:

FIRST: The name of the limited liability company filing these Amended and Restated Articles of Organization is DAYWORLD TRADE & SERVICES LLC (the "Company").

The Articles of Organization of the Company were filed with the Corporation Division of the Florida Department of State on February 4, 2019 under Document No. L19000028770.

SECOND: These Amended and Restated Articles of Organization were unanimously approved by the Members. The votes cast were sufficient for approval under the Articles.

THIRD: These Amended and Restated Articles of Organization supersede and take the place of the heretofore existing Articles of Organization and any and all amendments thereto:

**ARTICLE I
NAME**

The name of the limited liability company shall be DAYWORLD TRADE & SERVICES LLC (the "Company").

**ARTICLE II
PURPOSE**

The Company is authorized to engage in any lawful act or activity for which limited liability companies may be organized under the Florida Revised Limited Liability Company Act (the "Act").
