Pursuant to Section 605.0707 of the Florida Revised Limited Liability Company Act (the "Act"), Tier II, LLC does hereby submit the following Articles of Dissolution:

ARTICLE I – NAME

The name of the limited liability company is Tier II, LLC (the "Company").

ARTICLE II – FORMATION

The Company's Articles of Organization were filed on February 5, 2019. The Company was assigned document number L19000030101.

ARTICLE III – EFFECTIVE DATE

All or any of the Company's remaining assets and/or property have been distributed among the Members in accordance with her, his or its respective interests and rights.


ARTICLE VII – NO PENDING LITIGATION


The Company hereby certifies that there are no suits pending against the Company in any court.




