ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as amended from time to time (the "Act"), THE KENYON COMPANY, LLC (the "Company") hereby files these Articles of Amendment to the Articles of Organization of the Company in order to completely amend and restate the articles of organization of the Company filed on February 8, 2019 and assigned Florida document number L19000033693 as follows:

ARTICLE I - NAME

ARTICLE IV - ADDITIONAL MEMBERS

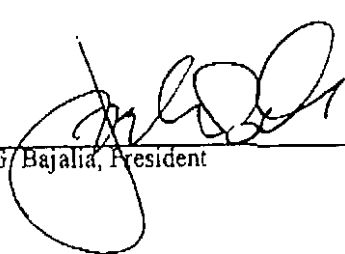
Additional members (as the term "member" is defined in §605.0102(40) of the Act) may be admitted at such times and on such terms and conditions as provided in the Operating Agreement.
