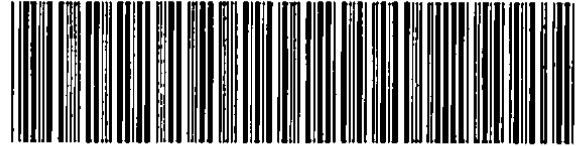


1. The name of the limited liability company is LirPro LLC.

**ARTICLE I - NAME**


The name of the limited liability company is Tocaro Blue LLC. This limited liability company is referred to in these Articles of Organization as the Company.
