ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, **Montessori Education Alliance, LLC** adopts the following Articles of Amendment to its Articles of Organization:

- FIRST:** The name of the limited liability company is Montessori Education Alliance, LLC (the "Company").
- SECOND:** The Articles of Organization of the Company were filed with the Florida Department of State on February 4, 2019, under Document Number L19000034342.
- THIRD:** The following amendments to the Articles of Organization were adopted by the Company:


Article III of the Articles of Organization is hereby amended and restated in its entirety to read as follows:
