# AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR KATIE ANN LLC

The undersigned, Nisarg Parikh, D.M.D., a natural person competent to contract and a member of KATTE ANN LLC, a Florida limited liability company (the "Company"), hereby presents these Amended and Restated Articles of Organization pursuant to the provisions of Section 605.0202, *Florida Statutes*. These Amended and Restated Articles of Organization have been duly adopted by the members of the Company.

FIRST: The Company's Articles of Organization, having an effective date of filing of February 01, 2019, were filed on February 04, 2019 with the Florida Department of State and assigned document number L19000034467.

SECOND: The Articles of Organization are superseded in their entirety by the provisions of these Amended and Restated Articles of Organization.

THIRD: The Company's Amended and Restated Articles of Organization are set: for their entirety as follows:

#### **ARTICLE I - NAME**
