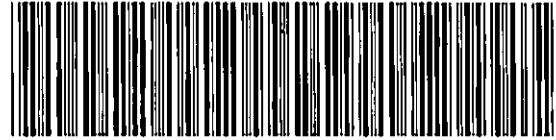

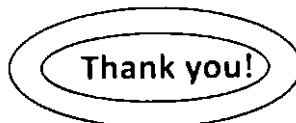

**ARTICLES OF ORGANIZATION
OF
TROPICAL SURVEILLANCE AND INVESTIGATIONS, LLC**

1. Name. The name of this limited liability company is **TROPICAL SURVEILLANCE AND INVESTIGATIONS, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Duration. The Company's existence shall be effective as of February 11, 2019 and shall thereafter be perpetual.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 1813 N. Tampa Street, Tampa, Florida 33602.


