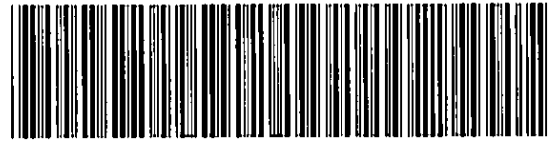




The only asset the LLC had was an apartment. The apartment was retitled in my and my wife's name so the LLC is no longer needed
