Pursuant to the provisions of Section 605.0202, Florida Statutes, Grove Kosher, LLC, a Florida limited liability company (the "Company"), which filed Articles of Organization with the Florida Department of State, Division of Corporations effective as of February 7, 2019, adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The following is hereby added as Article IV of the Company's Articles of Organization is hereby deleted and replaced with the following:

"ARTICLE IV

"The limited liability company is a manager-managed limited liability company, and management of the limited liability company is vested in its managers. To the extent inconsistent with the following listing, any existing managers of the Company are hereby removed, and the following persons have been appointed as the managers of the limited liability company:

Avery Eisenreich
Shlomo Goldman
David Sussman

"The managers shall remain as managers until removed or replaced in accordance with the terms of the Company's operating agreement, as the same may hereafter be amended.

"Furthermore, except for any authority expressly granted to any manager or officer of the Company in any operating agreement or other written document adopted pursuant to any operating agreement, no member, employee or other agent of the Company shall have any authority to bind or act for the Company or any other member in the carrying on of their respective businesses or activities."

This amendment shall take effect on the date of the filing hereof.
