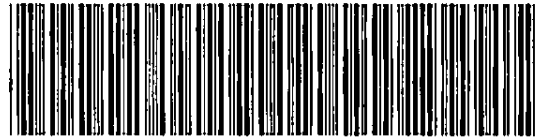




ARTICLE VII—MANAGEMENT
