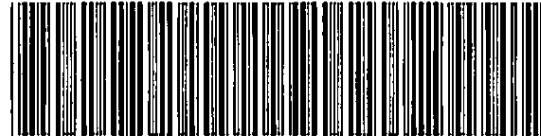

This correction is pursuant to Florida Statue s.605.0209(1)(d) is specific to a defect of not describing our corporate charitable mission purpose thereby erroneously filing the original articles of Organization and this must be corrected for accuracy as specified under Florida Statute s.605.0209(1)(e), aforesaid correction amendment Article V is submitted below.

Article V
