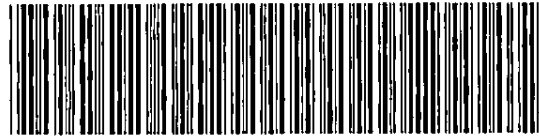

**ARTICLES OF ORGANIZATION
OF
PROVIDENT GROUP – PBAU PROPERTIES LLC**

The undersigned authorized representative, acting under and pursuant to the Florida Revised Limited Liability Company Act, §§ 605.0101, et. seq.) (the “Act”), does hereby submit the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is Provident Group – PBAU Properties LLC (the “Company”).

**ARTICLE II
PURPOSE**

The Company is organized to further the stated charitable purposes of Provident Resources Group Inc., a Georgia nonprofit corporation and an organization exempt from Federal income tax under Section 501(a) of the Internal Revenue Code of 1986, as amended (the “Code”), as an organization described in Section 501(c)(3) of the Code (the “Sole Member”). Specifically, the Company is organized exclusively for the purpose of promoting and advancing education through the planning, developing, designing, building, financing, furnishing, equipping, operating, and maintaining one or more student housing facilities and certain ancillary facilities located on the campus of Palm Beach Atlantic University (the “University”), a Florida nonprofit institution of higher education, in West Palm Beach, Florida, exclusively for the benefit and support of the University and its students, and assisting and otherwise supporting the educational mission of the University. The Company may engage in any lawful business activity permitted by the Act in furtherance of the foregoing charitable purposes.

**ARTICLE III
PUBLIC BENEFIT**

The Company shall operate exclusively in furtherance of the above stated charitable purposes and shall not engage in any activities that would jeopardize the tax-exempt status of the Sole Member. No substantial part of the Company's activities will be carrying on propaganda or otherwise attempting to influence legislation. No part of the net earnings of the Company or any of its operations shall result in private inurement or impermissible benefits to private interests or individuals, and all property of the Company shall be dedicated and used exclusively in furtherance of the above stated charitable purposes. The Company shall not be operated for pecuniary profit.

**ARTICLE IV
MEMBER**

Any member of the Company must be a nonprofit organization exempt from federal income tax as an organization described in Section 501(c)(3) of the Code, or an entity that is treated as a “disregarded entity” of such an exempt organization for Federal tax purposes. The initial member of the Company is: Provident Resources Group Inc., 5565 Bankers Avenue, Baton Rouge, Parish of East Baton Rouge, Louisiana 70808.

DISTRIBUTION OF ASSETS**


