The mailing address and street address of the principal office of the Company is 16763 Prato Way Naples, Florida 34110.

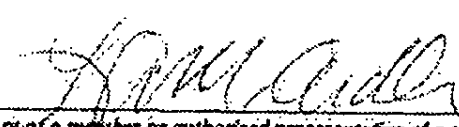
ARTICLE 3

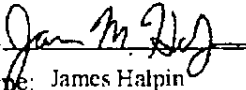
