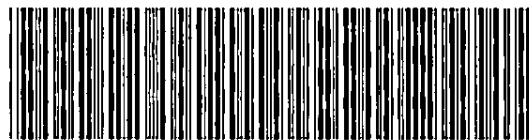



### **Purpose**


The purpose for which the Limited Liability Company is organized is to conduct any and all lawful business for which limited liability companies can be organized pursuant to Florida Statutes.
