The undersigned hereby submits these Articles of Organization (these "*Articles of Organization*") for purposes of forming Diruto Magna Pila, LLC, a Florida limited liability company, under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the Florida limited liability company formed pursuant to the filing of these Articles of Organization (the "*Company*") is Diruto Magna Pila, LLC.

ARTICLE II - ADDRESS

The mailing address of the Company is 6526 Kanner Hwy, #133, Stuart, Florida 34997 and the street address of the principal office of the Company is 6526 Kanner Hwy, #133, Stuart, Florida 34997.

ARTICLE III - INITIAL REGISTERED AGENT AND OFFICE

ARTICLE IV - ADOPTION OF OPERATING AGREEMENT

The Company shall be governed by a written operating agreement adopted by its member(s) (as amended from time to time in accordance with its terms, the "*Operating Agreement*"), which Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization or Chapter 605, *Florida Statutes*. The Operating Agreement shall identify the original member(s) of the Company. Additional persons shall not be admitted to the Company as members except in compliance with the procedures set forth in the Operating Agreement.

ARTICLE V - DURATION

The period of duration for the Company shall be perpetual unless dissolved in accordance with the terms of the Operating Agreement.

ARTICLE VI - MANAGEMENT

The Company shall be managed by one or more managers (each, a "*Manager*") appointed or elected from time to time in accordance with the Operating Agreement. The name and address of the individual who will serve as the initial Manager is Cindy Renee Boyer at 6526 Kanner Hwy, #133, Stuart, Florida 34997. Subject to the terms of the Operating Agreement, the Manager and the Member(s) shall be entitled to designate in writing one or more officers having authority to bind the Company.

ARTICLE VII - AMENDMENTS

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by a writing executed by a Manager of the Company.
