ARTICLE IV. MANAGEMENT

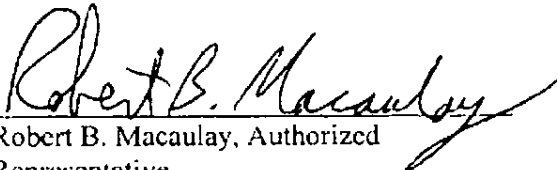
