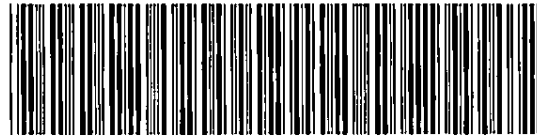

Management






