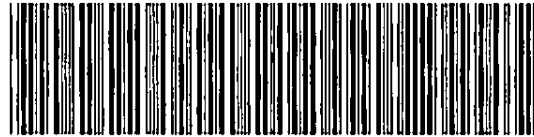

ARTICLE I

Voting




