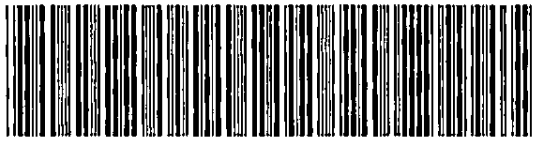

ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, adopts the following Articles of Organization:

ARTICLE I

Name


