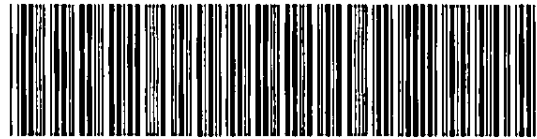

### **ARTICLES OF ORGANIZATION**
