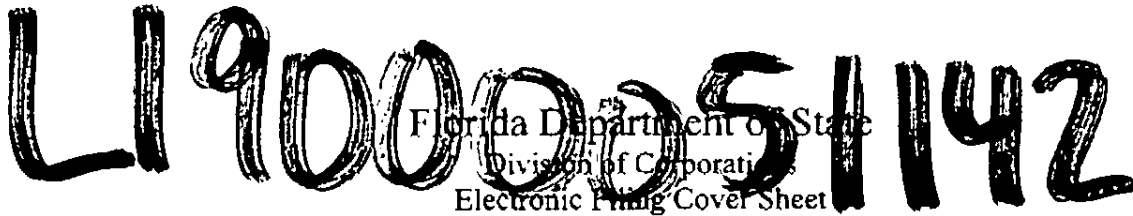

**ARTICLES OF ORGANIZATION**  
*of*  
**JAXS PROPERTY MANAGEMENT, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be Jaxs Property Management, LLC (the "*Company*"). The mailing and street address of the principal office of the Company in Florida shall be 1147 Salt Creek Dr., Ponte Vedra Beach, Florida 32082.

**ARTICLE II**

**PURPOSES AND POWERS**
