
ARTICLE VII NEW MEMBERS





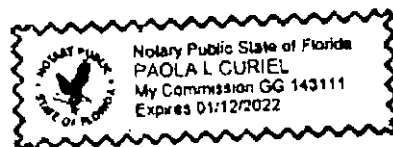
