1. I am over 18 years of age and have personal knowledge of the affirmations contained herein.
2. I am a former manager, member, and authorized representative of the dissolved entity, CannaFX, LLC (hereinafter "CannaFX Dissolved"), document number L15000125391.
3. CannaFX Dissolved was effectively dissolved by the Florida Department of State Division of Corporations (hereinafter "Division of Corporations") on September 28, 2018.
4. The managers and members of CannaFX Dissolved have no intention of having the entity formally reinstated by the Division of Corporations.
5. Therefore, the name CannaFX, LLC may be released by the Division of Corporations for use by another entity.
6. On February 1, 2019, I, as a manager, member, and authorized representative of the new entity, CannaFX, LLC (hereinafter "CannaFX"), filed the Articles of Organization for

7. All of the managers and members of CannaFX are the same as the former managers and members of CannaFX Dissolved.

8. The managers and members of CannaFX desire to open a new and separate entity from CannaFX Dissolved.

9. This affidavit, in conjunction with our recent application for a new entity with the CannaFX name, should be sufficient to allow the new entity to be accepted by the Division of Corporations.
