


1. The name of the limited liability company is BBF Land Management, LLC (the "LLC").
2. The Articles of Organization of the LLC were filed on March 5, 2019 and assigned document number L19000055716.
3. The dissolution was approved by all of the members of the LLC on December 28, 2020.




