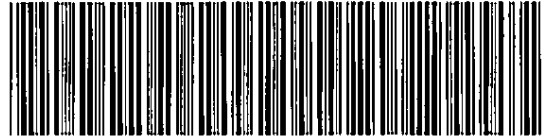


Due to circumstances beyond my control, effective today I can no longer continue with Benevolence Realty, LLC. Please accept this letter as my formal resignation from my role as manager.
