ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION
of
TWELVE 1412 LLC

These Articles of Amendment are unanimously adopted by all Members of the company to amend the Articles of Organization, to be filed with the Florida Department of State, as follows:

ARTICLE ONE: NAME

The name of the company is Twelve 1412 LLC.

ARTICLE TWO: DATE OF FILING

The Articles of Organization were filed on 28 February 2019 and were effective on 28 February 2019.

ARTICLE THREE: AMENDMENT

The Articles of Organization are amended by replacing Article V in its entirety with the following:


ARTICLE V

The Company shall be a manager-managed Company and it shall be managed by one or more Managers appointed by the Members in accordance with the Operating Agreement.

Until and unless changed by the Members in accordance with the Operating Agreement, the Company shall have one Manager and that Manager is Agency Agents, LLC, a Florida limited liability company, whose address is 3908 26th St W, Bradenton, FL 34205. Any Manager may be removed and other or additional Managers appointed by the Members in accordance with the Operating Agreement; provided, however, that the Company shall always have at least one Manager.
