ARTICLES OF ORGANIZATION OF FRANKLIN F. LUKE, PLLC

The undersigned, pursuant to the provisions of Chapter 621 of the Florida Statutes, as amended or replaced, for the purpose of forming a Professional Limited Liability Company ("Company") under the laws of the State of Florida, states the following:

ARTICLE I - NAME
