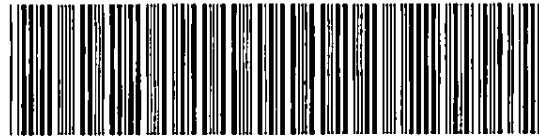

2. The name of the Company in the Articles of Organization as filed contained a typographical error, and as of the Effective Date (as defined below) no Membership Interests had yet been issued.


3. Accordingly, the Name of the Company shall be amended to read as follows:
