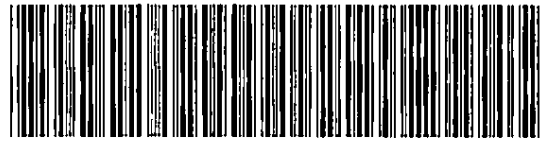

**ARTICLES OF ORGANIZATION
OF

These are the Articles of Organization of the Company identified below. They are being filed with the Florida Department of State pursuant to Chapter 605, Florida Statutes for the purpose of creating a limited liability company.

ARTICLE I - Company Name: The name of the limited liability company ("Company") being created with these Articles of Organization is: KWA GE' CREATIVES LLC.

ARTICLE III - Purpose: The purpose of the Company is to engage in any business activity allowed by law.


