## MANAGEMENT


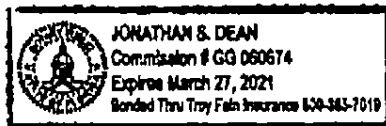
